Chief Justice Tore Schei:

RE: Brad Blanton Expert Witness Perjury to RE: Norway v. Breivik/Berwick: Application to Chief Justice Tore Schei ITO Article 85: Treason

My apologies. I have become aware of information and evidence proving such information as accurate; that evidence which I submitted to this court in this matter was erroneous / inaccurate.

On 26 July 2011; I filed a Notice of Application in terms of Article 85 of Norwegian Constitution, as laid down on 17 May 1814 by the Constituent Assembly at Eidsvoll and subsequently amended, most recently on 20 February 2007: Any person who obeys an order the purpose of which is to disturb the liberty and security of the Storting is thereby guilty of treason.

On 03 September 2011 I notified the court of my withdrawal of the application. Written Reasons: If Norway wants to be conquered by Muslims; and does not wish to take this opportunity provided to it to raise its citizens awareness of its impending European and cultural suicide; that is Norway's choice; which I shall honour and respect.

More specifically: At the time that I submitted the expert witness affidavit of Dr. Brad Blanton to this court; I believed that Dr. Blanton sincerely was committed to Radical Honesty; to honestly resolving the root causes of social conflict.

It has slowly become apparent to me that I was extremely naïve and that Dr. Blanton and his 'Radical Honesty' trainers are not remotely sincere about honestly resolving the root causes of – race, religion and class – resource war social conflict.

Awakening to Dr. Blanton's perjury has been a slow process; such as waiting for him to notify South African courts that he wishes to withdraw his expert witness affidavits – as per [my discussion with Brad Blanton and Radical Honesty Trainers; after I filed this application with Norwegian Oslo court in the matter of Norway v Anders Breivik; on the issue of free and fair trials for everyone, white or black, rich or poor, right wing or left wing --](#) and the perjury reasons for his withdrawal of his expert witness affidavits.

A copy of all the documentation and correspondence submitted to United States Federal Bureau of Investigation, the Police and District Attorney / Prosecutors Offices of the cities/towns wherein Dr. Blanton and his Radical Honesty trainers reside in USA, United Kingdom and Canada; and the Police Prosecutors Office's of George and Capetown; is available at: [FBI Fraud: Johnstone v Brad Blanton](#).

I sincerely apologize to Justice Schei, Mr. Breivik and 22 July Victims in this Norway v Breivik matter: for having attempted to provide the court with an affidavit from Psychologist: Dr Blanton; who it appears was committing perjury when he signed the expert witness affidavit; I submitted to this court.

Since the application was withdrawn for reasons cited; I guess it may not matter to any of the Norway v Breivik parties.

I have notified the South African Concourt Justices to which Dr. Blanton's affidavit was originally submitted; of Dr. Blanton's perjury; and that I am unclear of the correct procedure for fixing a perjured expert witness affidavit submitted to a court proceeding; and requested the Concourt Justices to kindly clarify (a) what the correct procedure is; if there is any; (b) what preference the Justices have for dealing with Dr. Blanton's expert witness perjury; if any.
